

BIKE, BREATHE, BELIEVE RIDE ACROSS AMERICA RELEASE AND WAIVER OF LIABILITY

For consideration of participation in the Bike, Breathe, Believe: Ride Across America (“BBB Ride”) event to be held beginning on March 10, 2020, and ending on April 25, 2020, I, _____, waive and release the organizers of the BBB Ride, its directors, representatives, past and present members, volunteers, agents, supervisors, participants, all state and local governments, and other persons (collectively, the “Releasees”), from any and all claims, liabilities, or causes of action arising out of an injury to me (or my child) and from any and all claims, liabilities, or cause of actions arising from my (or my child’s) participation or attendance in this event.

1. Inherent and Potential Risks

I understand that the BBB Ride involves strenuous physical activity associated with bicycling long distances potentially over the course of several days. I understand that physical activity, by its very nature, carries with it certain inherent risks. I assume all risks associated with participating in the BBB Ride relating to the risk of strenuous physical activity, collisions with other riders, vehicles, and pedestrians, or falling off of my bicycle. I acknowledge that I (or my child) may incur minor injuries, major injuries, and catastrophic injuries including paralysis and death. I assume all risks from contact with other participants and volunteers, negligent or wanton acts of other participants and volunteers, any defects of conditions of road surfaces (including uneven or wet road surfaces or gravel on the road surface), failure of cyclists, vehicles, and non-participants to observe traffic signals or laws, and the effects of weather including high heat, thunderstorms, lightning, precipitation, cold temperatures, high winds, and/or humidity. I assume all risks associated with consuming any food or drink during the BBB Ride. I am solely responsible for any adverse health effects from food or beverage consumption, regardless of any allergy, known or unknown, which I (or my child) may have. I agree not to consume alcohol or narcotics prior to or while cycling in the event. I acknowledge that my participation in the BBB Ride may involve an overnight stay and time off of my bicycle where I am still attending the BBB Ride event. I assume all risk for any and all activities in addition to cycling that I (or my child) engage in throughout the entirety of the BBB Ride event, including my (or my child’s) safety from the beginning of the BBB Ride to the conclusion of the event. I agree to dress myself (or my child) appropriately as to mitigate risk of physical injury to myself (or my child) including, but not limited to: wearing shoes appropriate for strenuous cycling involved in the BBB Ride; and dressing in conjunction with the weather. I understand that wearing a helmet that satisfies Consumer Product Safety Commission (“CPSC”) standards is a requirement to participate in the BBB Ride. I agree to wear a helmet that satisfies CPSC standards for the entirety of my participation in the BBB Ride. I agree that the Releasees are not responsible for any personal items or property lost or stolen before, during, or after the BBB Ride. I understand that the BBB Ride is an unsupported ride and that Releasees are under no obligation to provide support. I understand that in choosing to ride in an unsupported ride, I assume all risks associated with an unsupported ride, including but not limited to lack of signage, lack of law enforcement and traffic control, lack of aid stations, poor visibility, and a lack of assistance in case of an emergency. Weapons are strictly prohibited on the BBB Ride and at any BBB Ride associated events. I agree not to bring a weapon of any kind to the event, including all BBB Ride sponsored pre and post event activities.

2. Medical Evaluation

I attest that I (or my child) am medically and physically able to participate in the BBB Ride. If I experience any doubt as to my (or my child’s) ability to successfully and safely participate in and/or complete the BBB Ride, I take full responsibility for consulting a physician. I attest that, if I (or my child) am pregnant, disabled in any way, or have recently suffered an illness, injury, or impairment, I (or

my child) should have or did consult a physician prior to participating in the BBB Ride. I consent to emergency medical care and transportation in the event of injury to me (or my child) as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency, including, but not limited to, negligent emergency rescue operations.

3. Voluntary Participation

I am fully aware of the risks connected with participation in the BBB Ride, whether specifically listed in this Release or not, and I voluntarily elect to participate in the BBB Ride knowing that this participation involves these risks.

4. Assumption of Risk, Waiver of Liability, Release, and Covenant Not To Sue

In consideration for being permitted to participate in the BBB Ride, I voluntarily agree for myself, my family, heirs, assigns, executors, and administrators to the following: 1. TO ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me (or my child), or any loss or damage to property owned by me (or my child), as a result of participating in the BBB Ride 2. TO RELEASE, WAIVE, HOLD HARMLESS, DISCHARGE, AND COVENANT NOT TO SUE the Releasees from any and all liability, claims, actions, demands, expenses, attorney fees, breach of contract actions, breach of statutory duty or other duty of care, warranty, strict liability actions, and causes of action whatsoever, that I might have or may acquire in the future, arising out of or related to any loss, damage, or injury, including death, that may be sustained by me (or my child), or to any property belonging to me (or my child), while participating in the BBB Ride including, but not limited to, any claim that the act or omission complained of was caused in whole or in part by the negligence or carelessness of the Releasees.

5. Acknowledgment and Compliance with Rules

I agree to observe all rules and safety procedures that accompany the BBB Ride and to abide by any decision of an event official relative to my (or my child's) ability to safely participate in the event. I agree to exhibit appropriate behavior at all times and to obey all laws, including all applicable state and local laws and regulations governing cyclists. BBB Ride organizers and event officials may dismiss me (or my child), should my (or my child's) behavior endanger the safety of or negatively affect an event, person, facility, or property of any kind.

6. Severability

I agree that if any portion of this Release is deemed to be invalid, the remainder of the Release will still be binding and enforceable.

7. Photography and Website Release

I hereby grant full permission to the BBB Ride organizers to use, reuse, reproduce, publish, or republish any photographs, motion pictures, recordings, or any other record of my participation in this event, including all BBB Ride sponsored pre and post event activities, in any medium now known or hereafter developed, alone or in conjunction with other material, without restriction as to changes or alterations, as well as to use my name, voice, likeness, and/or other indicia of identity, for editorial, educational, promotional, advertising, and commercial purposes, including without limitation in connection with the solicitation of contributions and the furtherance of the objectives of the BBB Ride organizers. Further, I relinquish all rights, title, and interest in any and all photographs, motion pictures, recordings, or other records of the BBB Ride I may take or capture to BBB Ride organizers. I grant permission for the BBB

Ride organizers to publish and recognize my participation in the BBB Ride on its website found at www.bikebreathebelieve.org. I acknowledge and represent that I have carefully read and understand all terms of this Release and Waiver of Liability.
